Overview

Blue Cross Blue Shield of Michigan and Blue Care Network use Availity[®] Essentials as our provider portal. Availity Essentials is a multi-payer provider portal through which health care providers can look up member eligibility and benefits or claim status for patients with coverage through different health plans.

Each Availity Essentials user must have their own secure user ID and password that will enable them to work with Blue Cross, BCN and other participating payers in Michigan and to view information for those members.

Here's what you need to do to get started.

Is your organization registered with Availity Essentials?	What to do
Yes	Set up permissions, or roles, for users who need access to Blue Cross- and BCN-specific tools. For details, see Set up access to tools within Availity Essentials, including Blue Cross- and BCN-specific tools on page 3.
	Once Availity Essentials users have the appropriate permissions, they'll need to complete training on these tools. Users can find information about this in the <u>Availity Essentials user guide</u> .
	Note: Because you already use Availity Essentials, Blue Cross and BCN are automatically available to you in drop-down lists within Availity Essentials, listed as "BCBS Michigan and Blue Care Network."

Select an Availity Essentials administrator

Note: If your organization has already registered for Availity Essentials, you already have an administrator. Skip to <u>Set up access to tools within Availity Essentials, including Blue Crossand BCN-specific tools</u> on page 4.

Your organization needs to designate an Availity Essentials administrator who will complete the registration process. Typically, this is an office manager.

While each organization can have only one primary administrator, there are other administrator roles you can assign to help with certain tasks. Below is the information your primary administrator will need:

- Basic information about your practice, including your federal tax ID and National Provider Identifier, or NPI
- Permission from your organization's legal authority, such as an owner or senior partner, to agree to Availity's *Organization Agreement* on behalf of your organization

Tip: Make sure you're aware of and compliant with Availity Essential's system requirements. To do this, go to the Availity Essentials <u>Get Started</u>* webpage, scroll to the bottom of the page and click the *Requirements* tab.

Register for Availity Essentials

- If your provider organization doesn't have an NPI, open the <u>Register and Get Started</u> with <u>Availity Essentials</u>* webpage, click <u>Get Started</u>, click <u>What should I know before getting started</u>? and review the information in the <u>Atypical Providers</u> section.
 - **Important:** If you add your organization as an atypical provider, your hierarchy will update automatically with the PGIP quarterly snapshot. This means you won't have to individually manage your providers within Availity Essentials for Health e-BlueSM and Clarify Health.
- 2. Go to the Availity Essentials <a>Get Started* webpage.
- 3. In the Healthcare Provider section, click the *Create Account* button. The Create User Account page opens. (If you're a billing service, click the *Create Account* button in the Billing Services section.)
- 4. After completing the form fields on the Create User Account page, click *Continue*. The registration wizard will guide you through the rest of the process.
- 5. After you complete the registration process, Availity Essentials will send emails to you that include your next steps and a temporary password. You can then begin adding other users for your organization.

- o Each Availity Essentials user must have their own secure user ID and password.

Health e-Blue	Provides patient health reporting on conditions, treatment opportunities, pharmacy claims, diagnosis gaps and more.	Availity Essentials administrators: Set up and maintain Health e-Blue tools PDF
Clarify Health	Provides assessments of health care provider efficiency and quality	Availity Essentials administrators: Set up and maintain the Clarify Health tool PDF

Remove a user's access to Availity Essentials

When there are staff changes, Availity Essentials administrators can remove a user's access to Availity Essentials. To do this:

- 1. Log in to our provider portal (availity.com)*.
- 2. Click Maintain User under My Account.
- 3. Locate the user's account and click the user's name.
- 4. Click Revoke User.
- 5. Select the organization(s) from which you want to revoke the user. If the user belongs to a single organization, that organization is selected by default.

- 6. Optional: In the *Reason for Revoking User* field, enter a brief explanation of why you are revoking the user's access. Comments are limited to 80 characters.
- 7. Click Revoke.

Note: Before you can remove an Availity Essentials administrator's access to Availity Essentials, call Availity Client Services at 1-800-282-4548. They'll need to change the administrator who is on record before access can be removed.

How to identify all Availity Essentials users who are assigned to the administrator role

To view a full list of your organization's Availity Essentials administrators:

- 1. Log in to our provider portal (availity.com*).
- 2. Click your name (in the top navigation) and click My Account.
- 3. Click Organization(s).
- 4. Click Open My Administrators.
