A Blue Cross prior authorization pharmacist caught a dosing error that could have been fatal for an infant. The baby needed a specialty drug, Acthar® gel, to treat seizures. The case met prior authorization criteria. But the pharmacist noticed the doctor had mistakenly written the prescription for 400 units a day instead of 48. She called the doctor, who agreed, and the prescription was corrected. The baby received the right — and safe — amount of medicine.

The extra medication also would have cost an additional \$537,000 for this specialty drug.





Case study PRIOR AUTHORIZATION **SAVES THOUSANDS**

Asthma medicine Xolair® costs \$47,853 per patient each year. This drug requires prior authorization, to ensure that members are trying a lowercost alternative that has the same health benefits. The new drug pharmacists recommend when they review the cases costs only \$2,468 per patient each year. That's a savings of \$45,385 per patient every year.



INFUSION PROGRAM OFFERS SAVINGS, CONVENIENCE

Our infusion site of care program is moving infusions of certain specialty drugs from outpatient hospitals to lower-cost sites of care. The average cost for a hospital outpatient infusion is \$9,600. The average cost in other settings is only \$4,500.

The change saves money, but it gives members high-quality care conveniently, in the comfort of their homes, eliminating transportation and parking hassles and the possibilities for exposure to illnesses for compromised patients.

One member told us, "This is an amazing thing for us. ... Our family loves home infusion." Her middle school-age son needed to get up early for his hospital infusions, and then spend 90 minutes getting to school from there. Now, he can sleep later and nap or eat breakfast during his infusion, and he misses less school.

A partnership with Civica Rx and 17 other Blue plans will develop lower cost generic drugs for distribution starting in early 2022.

MEDICATION ADHERENCE

CREATIVE

We added new medication adherence programs in 2020 to improve member health, ultimately lowering medical and drug costs. The programs encourage members to follow their medication therapy as their doctors prescribed.

- Drug Adherence Discount Program, powered by Sempre Health Members receive bigger discounts each time they refill their prescriptions on time for certain medicines treating chronic conditions. In the first year of this program, participating members saved a combined total of \$1.8 million.
- High-Cost Drug Discount Optimization Program, powered by PillarRx Members benefit from maximized manufacturer copay assistance programs on specialty and other high-cost drugs. Self-funded group customers save an estimated 25% on the cost of the more than 300 drugs included in the program. That averages about 10% off their total prescription drug costs.

CELLULAR AND GENE THERAPIES MANAGEMENT **PROGRAM**

We use a mutli-disciplined approach to manage these drugs that can range in cost from \$100.000 to \$3 million for one treatment. The result is providing access to life-changing care for members while protecting group customers from unexpected high costs.

Here's how we do it:

- Closely monitor the drug pipeline
- Proactively manage costs through manufacturer and provider negotiations
- Continuously develop medical policies and guidelines
- Provide pathways for personal member experiences and care
- Include cellular and gene therapies in stop-loss coverage
