## **Topic: Provider Self Treatment and Treatment of Immediate Family Members**

## **Background:**

Providers are often asked to provide direct care to immediate family members or for various reasons choose to attempt to care for themselves. The delivery of such care has broad implications that carry significant ethical, quality and utilization concerns. Self and family treatment have been generally discouraged by the provider community. Organized medicine also has not been supportive of such care. An American Medical Association medical policy statement issued in June 1993 declares:

"Providers generally should not treat themselves or members of their immediate families. Clinical objectivity may be compromised ... the physician's personal feelings may influence his or her professional medical judgment, interfering with the care being delivered."

There are also issues involving "informed consent" where a physician's willingness or ability to fully inform a patient may be impacted by a close family relationship or, a family member may be disinclined to fully exercise patient prerogative when the patient-doctor relationship is complicated by family dynamics.

American Medical Association Journal of Ethics May 2012, Volume 14, Number 5: 396-397. The AMA Code of Medical Ethics' Opinion on Physicians Treating Family Members: "physicians should generally not treat themselves or immediate family members due to potential conflicts with professional objectivity, informed consent, and patient autonomy; however, in limited situations like emergencies or when no other qualified provider is available, and also for short-term minor problems, it may be permissible to provide care to close family members".

Additionally, there is unfortunate risk of fraud or prescription drug abuse that is very difficult to monitor or manage when family members are recipients of the care.

## Medical Policy Statement:

Provider self-treatment and treatment of immediate family members are not recommended and considered non-covered care.

Physicians should not bill BCBSM for services within their scope of practice rendered to immediate family members or to themselves. These are services that they would customarily receive compensation for when provided to non-family members.

While it is understood that Providers may occasionally order prescriptions for family members or even provide emergency care for them, these services will not be considered covered services where the physician seeks compensation for the services provided. This policy does not affect payment made to a licensed pharmacist for filling a prescription written by a physician for a family member.

For purposes of this policy, immediate family is defined as: spouse or domestic partner; natural, adopted, or step-children, grand-children, siblings, parents, parents-in-law, or grand-parents.

Scope:

This policy applies to all underwritten and self-funded, ASC contracts.
