# Blue Cross physician organizations and BCN medical care groups

Administrative entities for primary care providers, including BCN medical care group endorsement guidelines

For Blue Cross commercial, Medicare Plus Blue<sup>SM</sup>, Blue Care Network commercial and BCN Advantage<sup>SM</sup>

This document presents a list of Blue Cross Blue Shield of Michigan physician organizations and their corresponding Blue Care Network medical care groups. Blue Cross and BCN encourage primary care providers to align with a Blue Cross PO and its BCN MCG to receive support for all the Blue Cross and BCN lines of business in which the PCP chooses to participate. This includes Blue Cross and BCN commercial and Medicare Advantage plans (Medicare Plus Blue<sup>SM</sup> and BCN Advantage<sup>SM</sup>).

Alignment between the PO and MCG must occur before January 1, 2026, but PCPs should consider their options now. Working with a Blue Cross PO and its related BCN MCG will maximize efficiency for Blue Cross and BCN reporting, incentives and value-based contracting, reduce administrative burden on PCPs and result in more time for patient care.

#### How to use this document

Reach out to POs on this list to inquire about participation requirements and the benefits and services they offer. Be sure to select a PO and MCG that are aligned. They are shown in the same row in the table below.

If you're not sure of your region, you can view our region map.

#### Note:

- A PCP can participate in the Blue Cross networks without aligning to a PO. However, Blue Cross encourages PCPs to join a PO to maximize value-based reimbursement, incentive opportunities, and opportunities for a value-based contract.
- In some cases, a PCP may be able to participate in the BCN and BCN Advantage networks without aligning to a PO/MCG entity, but participation is limited based on the needs of the network. BCN encourages PCPs to join a PO/MCG entity to benefit from incentives, value-based opportunities and administrative support.
- PCPs with the Upper Peninsula Health Group physician organization do not need to align with a BCN MCG as there is currently not a corresponding MCG to the Upper Peninsula Health Group PO.
- PCPs and specialists that wish to contract with BCN, should review the BCN medical care group endorsement guidelines below.

## **BCN** medical care group endorsement guidelines

### For Primary Care Providers (PCP):

Blue Care Network lines of business include: Blue Care Network (BCN commercial HMO) and BCN Advantage, an HMO Medicare Advantage plan.

In all four regions (East, Mid, Southeast and West), primary care providers must join an existing medical care group, or MCG. BCN may make exceptions in rural, low access areas. The MCG medical director with whom you intend to participate must countersign the contract signature document.

To participate as a PCP, a provider must be board certified or board eligible in one of the following specialties: internal medicine, family practice, geriatrics or pediatrics. A practitioner can be a physician or a nurse practitioner. Applicants should contact a few POs/MCGs to inquire about their contractual requirements with BCN, performance in the BCN network and the MCG's requirements for membership. A PCP must align with one PO/MCG entity before January 1, 2026.

To assist you in selecting, the table below contains contact information for each PO/MCG.

#### For Specialists:

A specialist provider can be endorsed by one or more MCGs to create a mutually beneficial relationship between a specialty provider or group of specialty providers and the MCG. The relationship provides the specialist the opportunity to gain a base for referrals from the MCG's affiliated PCPs. The MCG gains by having the ability to monitor the quality of care and the ability to negotiate a risk-sharing arrangement with the specialty provider.

To be endorsed by an MCG, the specialist should contact an MCG on the list below who will send in paperwork on behalf of the specialist.
