

## 2019 HEDIS® Advanced Illness and Frailty Exclusions Guide

In 2018, the National Committee of Quality Assurance allowed additional exclusions to Healthcare Effectiveness Data and Information Set star measures for patients with advanced illness and frailty.

Services measured by NCQA may not be of benefit to older adults with limited life expectancy and advanced illness. Also, unnecessary tests or treatments could burden them or even be harmful. NCQA wants providers to focus on appropriate care for their patients.

#### STAR MEASURE EXCLUSION CRITERIA

Codes must be billed in the measurement year or the year prior to exclude the patient from the star measures in the table below.

### **Frailty**

These codes include equipment that is typically submitted on claims such as hospital beds, wheelchairs and oxygen. However, there are ICD-10 codes that are not always routinely included on claims, (examples: weakness, fatigue, falls).
