Update: We'll stop accepting mo faxed requests for commercial SNF admissions starting June 1

Starting June 1, 2022, skilled nursing facility prior authorization requests must be submitted through the e-referral system. Faxes will only be accepted for urgent requests when the e-referral system isn't available. This applies to SNF requests for initial admissions and additional days for Blue Cross and BCN commercial members. Read more:
