For dates of service on or after Sept. 1, 2023, additional services will require prior authorization by Carelon Medical Benefits Management (formerly known as AIM Specialty Health®). The codes that Carelon will begin managing on Sept. 1 can be seen in the updated document titled *Procedures that require prior authorization by Carelon: Cardiology, radiation oncology, radiology (high technology) and sleep studies* (*in lab*).
