Reminder: Independent labs must provide advance notice to Blue Cross commercial members before providing noncovered services

Before receiving noncovered services at independent laboratories, Blue Cross commercial members must sign the Advance Notice of Member Responsibility form. Reminder: Include preadmission testing services on inpatient claim
