2016 performance recognition program payment delay

Please be advised the Patient-Center Medical Home/ Provider Group Incentive Payment pay as you go portion of the performance recognition program payment, for the measurement period of January through June 2016, will be delayed until July 2017. Blue Cross Complete will provide payment for the entire calendar year of 2016 in July 2017 which is in alignment with the MCG bonus payment schedule. This change in schedule is to accommodate the collection of the PCMH/PGIP certification and level of meaningful use attestations which will be sent to the offices in the fourth quarter 2016.

More information regarding the PCMH/PGIP attestation will be provided soon.

Chlamydia screening urine test

Some female adolescents and young adults ages 16 to 24 years and others who are high risk for chlamydia may decline a pelvic exam during the preventative exam, but should still be screened for Chlamydia.

A simple urine test is an effective method. This important test should be routinely performed during a patient's annual wellness exam.

The following laboratory tests are available:

- Chlamydia Took Kit: CPT code 87491, or
- Chlamydia urine test: CPT code 87591
